People had gotten over the mountains

But never penetrated the jungle

### Evangelicos

Although oil was discovered out there in the 1920s & 30s

It was not until WWII missionaries from Wycliff Bible Translators

& Summer institue of Linguistics penetrated the jungle

Rachel Saint oversaw

Dropping trinkets to the Indians until they could safely enter

Oil Company Logos Once the indigenous population was pacified Oil companies came in and started pumping oil out in 1972

#### **Toxic Pollution**

Huge oil spills

When Texaco left in 1993

Left behind 1,000 open toxic waste

dumped more than 18 billion gallons

of toxic and highly saline "formation waters

a practice outlawed in major US oil producing states

Cause for a huge lawsuit Cancer & rashes

# **Traditional Ecuadorian Political Class**

Sierra landed aristocracy from Spanish colonial times, Serf system Coastal cash crop plantations - 1880's cacao

Power went back and forth between the Aristocracy in the Sierras & the Coast

## Oil Economy

Industrialized jungle

Pumps & distribution plants

500,000 barrels per day (bbl/d) of petroleum,

3<sup>rd</sup> biggest in Latin America

Brought the competing political classes together
To exploit economic potential of Ecuador's Oil
Brought Billions of Dollars into the economy
Ecuadorian Political class responded with delight

# Organization of Petroleum Exporting Countries

They joined OPEC

Cartel of Oil producing countries

Created in the 70s

Creating gas lines in the seventies

& higher prices

Doing monopoly capitalism

Brought hoards of cash into the OPEC sovereign treasuries

Creating a financial power base in the Middle East

Instigated the beginning of what we now call corporate globalization.

Here is the standard history

Western powers worried about independent money base in the middle East

John J McCloy

To understand we have to look back to the end of WWII & John McCloy

He has quite a resume

After he engineered West Germany's reintegration into the West

Handled diplomatic problems for US around Israel & the Middle East

As President of Chase Manhattan & the Council on Foreign Relations

State Department dealt with Israel,

McCloy dealt with the Arab countries

# Chase & Citibank symbols

That close Relationship led OPEC countres to Deposit \$ in Big Banks

Banks had to find a way to invest the money

They went back to the sovereign govts aroud the world Lent them money for development projects

# Confessions of an Economic Hitman / NED

Two critical Programs of this Imperial Effort

Perkins Trained by the NSA

To convince govt to do expensive development projects Borrow from big Banks To drag these economies into the global commercial empire Intermediary strategy before military intervention

## NED/

Converted CIA program to create regime change around the world Funded with Federal Dollars Active in Ukraine

# Electricity/ Mall Picture

Ecuadorian political class used future oil revenues as loan collateral So the govt. started borrowing money for all kinds of projects,

Roads, electrification

But also projects

Benefited the wealthy Benefited big business

Never created the economic returns to pay off the loans At least benefited the govt. contractors

### Chart of Debt

Follow GNP, Debt & Interest since 1970
Interest payments rise in the 80s
Crisis by 1999, debt repayment is 40% of economy
Ecuador & many other countries were having a hard time paying debts
When countries had trouble paying off private banks
Banks turned to the IMF & Changed histroic role

IMF slide Mid 90's IMF changed its mission stepped in Bailing out govts with Structural Adjustment loans

## Structural adustments

Austerity measures- Structural adjustment programs

Prohibited Price Subsidies

That were providing necessities to the poor

Adjusted govt spending away from providing services

And toward paying off the loans

Both Medical and educational expenditures were reduced

Between 86-99 Education reduced by 25% & Agricultural assistance cut by 80%

Industries are privatized

Electrical & Phone

Expand cash crops

beatings of workers at the hands of Bonita thugs

IMF loans bought Brady bonds that restructed sovereign debts

So the govts could pay back the big banks

At the same time the World bank concentrated on lending for projects that would enhance the cash crop economy

### Dollar slide

Crisis in 1999

Banks closed

Ecuador goes broke on the Brady bonds

Most heavily indebted of any LA country

\$14 billion

Global financial powers decreed that Ecuador would dollarise

### **Dollarisation**

International Financial leaders

convinced Ecuador they had to drop their national currency

& adopt the US Dollar as the their national currency

Raised prices, caused liquidity crunch

Exchange rate was the worst impact

25ECS=\$1.00 1970

25,000ECS=\$1 late 1999

Middle class really suffered, losing most of their savings elites had dollar accounts, middle class & peasants were broke

# Trade Agreement Logos

Next thing to come down on Ecuador

Free trade agreements get rid of restrictions on capital

Foreign capital Threatens loss of local business, services and land Argument is not against trade – civilizations have always traded

Free Trade Regime started with NATA & WTO

Words of Renato Ruggerio:

"We are writing the constitution of a single global economy WTO stalled after 1999 & Seattle

FTAA developed as a runaround Protests defeated it in 2003 Miami

## TRIPS & GATS SLIDE

Other problems with the trade agreements Under WTO

Secret trade tribunals can nullify nation, state & local laws

Under Chapter 11 NAFTA, Corps can sue

<u>Investor to State Dispute Resolution</u>Overthrowing all laws that impinge on corporate profits

Now corporations are equal to nations

Dealing with intellectual property rights

Protecting corporate patents
Facilitating theft of indigenous knowledge

## General Agreement on Trade & Services

threatens to spread privatization into spheres of public trust like water and the justice system

Free trade agenda not about free trade

About controlling cheap labor and giving free range to capital

**Suing Texaco** 

18 billion gallons of toxic wastewater, spilled roughly 17 million gallons of crude oil left hazardous waste in hundreds of open pits

The lawsuit, first filed in 1993 in New York,

was refiled in 2003 in a Lago Agrio

In successive rulings in 2011 and 2012, judgment against Chevron:

\$19 billion clean up contamination &

provide health care and potable water to area residents.

Huge fight back & forth, witnesses bribed, lawyers discredited 2015 Canadian Supreme Court said Ecuadorians could seize \$10 billion

## <u>Tree sitters & Jenny at gate</u> Meanwhile back in Mindo

International effort to stop the OCP organized by Accion Ecologica All of NW pichincha opposed
